Eligibility: In order to qualify for the Delaware Certified Thoroughbred Program, a horse must reside in the State of Delaware for ninety (90) consecutive days, prior to March 31<sup>st</sup> of 2-year-old year. See page 2 for details.

## AFFIDAVIT OF CERTIFICATION INFORMATION

I, the undersigned, hereby certify that, pursuant to the information given by me above, this thoroughbred is eligible for certification as a Delaware Certified Thoroughbred, and participation in the Delaware Certified Thoroughbred program. I assume full responsibility for the registration of this horse, and agree that if the horse is later proved to be ineligible based upon false or fraudulent information provided by me: 1) the horse shall no longer be considered a Delaware Certified Thoroughbred; 2) I may be forever denied the privilege of Delaware Certified Thoroughbreds; 3) I may be forever denied any and all certifier awards in Delaware; 4) Any awards paid based upon the performance of an ineligible horse shall be returned in full by the recipient to the Delaware Certified Fund; and 5) I am subject to any and all civil and criminal penalties associated with providing fraudulent information under the laws of the State of Delaware.

# INSTRUCTIONS

Application must be submitted within ten (10) days of the thoroughbred's arrival at an approved DCTP farm or training facility. Days WILL NOT count until ALL paperwork has been submitted. If purchasing at a sale, send in pictures immediately and papers as soon as they are available.

## MUST INCLUDE WITH THE APPLICATION:

1. Copy of Jockey Club Registration Papers and/or four current pictures of the thoroughbred; front, back and both sides, making sure all white markings are clearly visible.
2. FEES
  - A) Weanlings - A check in the amount of \$100.00 made out to the DCTP before 12/31 of Weanling year.
  - B) Yearlings - A check in the amount of \$200.00 made out to the DCTP before 12/31 of Yearling year.
3. Completed Internal Revenue Service W-9 Form. Certifier information on application should match W-9 form.

## Registration Eligibility:

In order to be eligible for certification, horses must complete a minimum of ninety (90) consecutive days on an approved DCTP farm or training facility before March 31<sup>st</sup> of their two-year-old year. Certification applications will not be accepted after December 31<sup>st</sup> of the yearling year. Certification certificates will not be issued until the farm manager or owner has provided written verification that the thoroughbred was on their facility for the full ninety (90) consecutive days. Upon signing this application, the certifier understands that he/she is granting permission for an authorized agent of the DCTP to inspect the thoroughbred on the facility at any time during the ninety (90) day requirement, and further understands that documentation may be requested by the DCTP.
